With effect from 1 January 2015, BDO Unibank, Inc. Hong Kong Branch ("Branch") is a Category 2 institution (being an institution not designated as a Category 1 institution) and is required to comply with all the requirement of the Banking (Liquidity) Rules ("Rules") that are applicable to it insofar as those requirements relating to the Liquidity Maintenance Ratio ("LMR"). Being a Category 2 institution, Liquidity Coverage Ratio, Net Stable Funding Ratio and Core Funding Ratio are not applicable to the Branch.

As an authorised institution incorporated outside Hong Kong, LMR is calculated on the Branch basis pursuant to rule 10(1)(a) of the Rules.
