Template OV1: Overview of RWA

The table below provided an overview of RWA as at 31 March 2019 and 31 December 2018 respectively and the related minimum capital requirements by risk type as at 31 March 2019. The Company has adopted standardized approach for both credit risk and operational risk. During the first quarter of 2019, RWA increased by HK\$89.5 million to HK\$5.76 billion. The increase of RWA was mainly due to an increase in credit risk for non-securitization exposures related to loans and advances.
