The table below provides an overview of RWA and the related minimum capital requirements by risk type. The Company has adopted standardised approach for both credit risk and operational risk. During the first quarter of 2025, RWA decreased by HK\$806.57 million to HK\$4.05 billion, mainly due to decrease in operational risk arising from the changes in Banking (Capital) Rules effective on 1 January 2025.
