The increase in the total capital ratio over the reporting periods was mainly due to the decrease in the total RWA, which was in turn attributed by the decrease in the core business of loans and advances to customer and investment in debt securities. The increase in the LMR over the reporting period was mainly due to the decrease in qualifying liabilities arising from the decrease in Company's bank borrowing maturing within LMR period and the decrease in loan commitment, and the increase in the eligible loan repayment arising from the loans and advances to customer maturing within LMR period.
